- 1) **Entries:** a) All divisions \$90, Double entries: not accepted. b) Check payable to **Lord Creek Farm Events** c) Refunds: Before CD less \$10 fee; after CD less \$25 if place can be filled from waiting list & Veterinarian's certificate. Competition cancellation less \$25. d) Neg. coggins & rabies within 12 months must be included with entry. E) Lost pinney \$25
- 2) **Tentative Time Schedule:** Sat: Cross-Country course open 3 pm. **Elementary** - Sun: Dressage 8 am, Stadium, X-Country; **BN, N** Dressage 8 am, Cross-Country 11 am, Stadium 2 pm. Times are approximate.
- 3) **Awards:** Trophy & Ribbons per division. Special awards include: Lord Creek Challenge to Novice low score of the day and The Mary Schmidt Memorial Dressage Award for the best dressage score of the day.
- 4) **Starting Times:** Include email address or SAS postcard.
- 5) **Veterinarian/Farrier:** On grounds
- 6) **Directions:** **From I-95 north**, exit 70, end of ramp go left onto 156N, go 2.6 miles to Lord Creek Farm on left. **From I-95 south**, exit 70, at end of ramp go straight onto Halls Rd. ¼ mile to light, turn right onto 156N, go 2.6 miles to Lord Creek Farm on left. **From RT 11**, south to Rt. 82W, go south on 156 for 6 miles to Lord Creek Farm on right.
- 7) **Dressage:** Elementary, BNH, BNR 2002 USEA Novice Test C
ON 2002 USEA Novice Test D, Arenas: small grass
- 8) **Cross-Country:** **Elementary** 2'3" untimed, start is closer to trailer area; **BN** m @ 325 mpm, max fence height 2'7", **N** m @ 350 mpm. max. fence height 2'11". BN & N start is 1 mile along dirt drive from parking area. Competitors must ride out to cross-country and back: All courses straightforward, varied terrain, open and wooded, spectacular views of Connecticut River.
- 9) **Other Information:** Entries limited. Cross-Country Course Closed Aug. 5, 2004. Dogs on leashes. Food available on grounds. Divisions divided/combined if entries warrant. Cars can be driven to start until Cross-country begins. A shuttle service will be provided.
